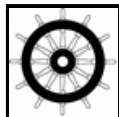

1. A layer of Ardex P82 (primer)
2. A layer of max. 20 mm Ardex K 40 (primary deck covering)

Density: approx. 1.5 kg/l

Application/Limitation

Primary deck covering, not generating excessive quantities of smoke nor toxic products in a fire.

Approved colour:	Grey and brighter colours
Max. organic content:	4.1 %
Mixing ratio:	6 ¼ liters of water per 25 kg of powder Ardex K40

Not to be used as an integrated part of horizontal class A division, unless tested as such.

The product may be applied over any steel or non-combustible material.

The product may also be used as floor covering in accordance with IMO 2010 FTP code Part 5 appendix 4 paragraph 4.9.2.

Each product is to be supplied with its manual for installation and use.
